What are the CANSTAR Package Home Loan star ratings?

CANSTAR *Package Home Loan star ratings* are a consumer friendly benchmark or value index. CANSTAR star rated products represent a short list of financial products. This short list narrows the search for consumers to products that have been independently assessed and ranked. Five-star rated packaged banking products have been assessed as offering outstanding value to consumers.

The CANSTAR *Package Home Loan star ratings* is based on two separate consumer profiles: Home Buyer and Property Investor.



Package Home Loan producs must offer a mortgage, credit card, and transaction account in order to qualify for assessment. The CANSTAR *Package Home Loan star ratings* is an independent and transparent analysis comparing both the Cost and Features across packaged banking products.

How are the stars calculated?

Features and costs for each product are taken into consideration, as well as over 200 features.

How many products and financial institutions were analysed?

CANSTAR analysed 64 packaged banking products from 46 financial institutions in Australia.

How often are all the products reviewed for rating purposes?

All ratings are fully recalulated every six months based on the latest features offered by each institution. CANSTAR also monitors rate changes on an ongoing basis.

What do the ratings mean?

Ratings range from five to two stars. Five-star rated products have been assessed as offering outstanding value to consumers.

How are the stars awarded?

The total score received for each profile ranks the products. The stars are then awarded based on the distribution of the scores according to the methodology guidelines. Due to the small number of qualifying products in the Package Home Loan sector, only a maximum of three products from each profile achieve a five-star rating.

Does CANSTAR rate other product areas?

CANSTAR researches, compares and rates the suite of banking and insurance products listed below. These star ratings use similar methodologies to guarantee quality, consistency and transparency.
